

## Rules for the "Sport Winners" competition by FOLAN

### Article 1 - Organisation

The company FOLAN, designer and manufacturer of fibre optic equipment, whose registered office is located at 692 rue des Mercières, 69140 Rillieux-la-Pape, FRANCE, is organising a competition entitled "Sport Winners" (hereinafter referred to as the "competition"), which will take place during the FTTH Conference from 19 to 21 March 2024 in Berlin, GERMANY.

### Article 2 - Conditions of Participation

2.1. The competition is free and open to any natural person over the age of 16, resident in France and abroad, regardless of nationality, with the exception of all employees of the company FOLAN and their relatives. Any participant who is a minor must nevertheless obtain the prior authorisation of one of his/her two parents or his/her legal guardian in order to take part in the game.

2.2. Participation in the competition implies irrevocable and unreserved acceptance of the terms and conditions of these rules (the "Rules"), which are available to download from the FOLAN.net website at the following address: <https://www.folan.net/en/folan-at-ftth-conference-berlin-2024/>

2.3. The competition is limited to one entry per person (e.g. same surname, same first name and same email address). Participation in the competition is strictly personal and nominative. Only one prize will be awarded per winner.

2.4. Failure to comply with the conditions of participation set out in these Rules will invalidate the Participant's participation.

2.5 The game is subject to the regulations of French law applicable to games and competitions.

### Article 3 - How to take part

To take part in the competition, visitors to FTTH Conference Berlin 2024 should visit the FOLAN stand (Hall 25 Stand S05) and follow the instructions given by the stand staff.

### Article 4 - Conduct of the competition

The competition will take place as follows:

1. Participants must complete a race on the Wii game "Mario & Sonic at the London 2012 Olympic Games" to validate their entry.
2. Each eligible entrant will be entitled to one entry only.
3. Each participant, who fills in the registration form available at the FOLAN stand reception desk (providing the required information) and deposits it in the ballot box provided for this purpose, obtains a chance to be drawn.

### Article 5 - Prizes

There are three prizes up for grabs in this competition:

- On Wednesday 20 March 2024: a Garmin Forerunner 55 smartwatch (worth €169.99).
- On Thursday 21 March 2024: a pair of JBL Live Pro 2 TWS wireless earphones (worth €149.99)
- On Thursday 21 March 2024: a Nintendo Switch Lite console (worth €199.99)

### Article 6 - Designation of Winners

The winners will be selected as follows:

- Wednesday 20 March 2024 (Garmin Forerunner 55 smartwatch): prize awarded to the participant who achieves the best time in a 100-metre race on the Wii game "Mario & Sonic at the London 2012 Olympic Games" during the day of Wednesday 20 March 2024 from 8.30am to 6.30pm (exhibition opening times).
- Thursday, March 21, 2024 (a pair of JBL Live Pro 2 TWS wireless earphones): prize awarded to the participant who achieves the fastest time in a 100-metre race on the Wii game "Mario & Sonic at the London 2012 Olympic Games" on Thursday, March 21, 2024 from 8:30 a.m. to 4:00 p.m. (show opening hours).

- Thursday, March 21, 2024 (Nintendo Switch Lite console): prize offered to the participant drawn at random from all the participants in the competition. Draw will take place on Thursday 21 March 2024 at 3.15pm.

The number of winners and the prizes to be won will be specified in the competition communication.

#### **Article 7 - Prize-giving ceremony**

The Organiser of the competition will only contact the Winners of the competition by e-mail and will inform them of their prize and how to access it. No mail will be sent to participants who did not win; only the winners will be contacted. The winners must reply within two (2) days following the sending of this e-mail and provide their full contact details. If no response is received from the winner within two (2) days following the sending of this e-mail, the prize will be forfeited and the winner will not be entitled to any indemnity, prize or compensation whatsoever. In this event, the following two (2) prizes (Garmin Forerunner 55 smartwatch; pair of JBL Live Pro 2 TWS wireless earphones) will be awarded to the participant who achieves the 2<sup>e</sup> best time in the 100-metre race on the Wii game "Mario & Sonic at the London 2012 Olympic Games". The 3<sup>e</sup> prize (Nintendo Switch Lite console) will be awarded to the alternate designated in the draw for the session in question. Winners must comply with these rules. If it turns out that they do not meet the criteria of these rules, their prize will not be awarded to them and will be acquired by the Organiser. To this end, participants authorise all checks concerning their identity, age, contact details or the fairness and sincerity of their participation. Any false declaration, indication of false identity or contact details will result in the immediate elimination of the participant and the acquisition of the prize by the Organiser. In addition, in the event that the Organiser is unable to deliver the prize won to the winner(s), for whatever reason, the Organiser reserves the right to substitute a prize of equivalent value, to which all participants agree.

#### **Article 8 - Use of Personal Data**

In accordance with the French Data Protection Act of 6 January 1978, participants in the competition have the right to access, rectify (i.e. supplement, update and block) and withdraw their personal data from the Organiser. Participants' personal information is collected by the Organiser solely for the purposes of monitoring the competition, and is essential for participation in the competition. The personal data collected as part of the competition will under no circumstances be communicated to third parties without the consent of the participants.

#### **Article 9 - Liability**

The Organiser may not be held liable if it is impossible to contact each winner, nor in the event of loss, theft or damage to the prize during transportation. Nor can the Organiser be held liable for any errors in the name, address and/or contact details provided by the people who took part in the competition. Furthermore, the Organiser of the competition declines all responsibility for any incidents that may occur during the enjoyment of the prize awarded and/or due to its use and/or its consequences, in particular the enjoyment of a prize by a minor, who remains under the full and total responsibility of a person with parental authority. The Organiser reserves the right, if circumstances so require, to shorten, extend, modify, interrupt, postpone or cancel the competition, without incurring any liability. However, these modifications will be communicated to participants by any appropriate means and will be the subject of an amendment which will be posted on the Site. The Organiser declines all responsibility in the event of a malfunction preventing access to and/or the proper running of the competition, in particular due to external malicious acts. The Organiser may cancel all or part of the competition if it appears that fraud has occurred in any form whatsoever. In such a case, it reserves the right not to award the prizes to the fraudsters and/or to prosecute the perpetrators of such fraud before the competent courts.

#### **Article 10 - Acceptance of the Rules**

Participation in the competition implies unreserved acceptance of these rules in their entirety.

#### **Article 11 - Applicable law**
